Please be advised that the undersigned represents G.Z. recipient of Supplemental Security Income disability benefits.

Mr. Z. was recently involved in a divorce. For your information, as stated in the Dual Final Judgment of Divorce, an appropriate alimony award and the equitable distribution of the marital property, was adopted by both parties. It was agreed that my client's former spouse would satisfy all financial obligations by paying my client, Mr. Z. a lump sum payment of \$95,000, payable to the trustee of a self-settled special needs trust, established by the Court, due to Mr. Z.'s disability. This Trust meets the requirements of the Social Security program.

Enclosed please find two (2) copies of the following documents:


