Andrew's comment: *"This suspension is illegal disability discrimination and clear ADA complaint retaliation, as explained by the Virginia State Bar, which refused to follow suit, complaining that what the Indiana ADA coordinator did "had all the grace and charm of a drive-by shooting." VSB stated that I met the clear and convincing evidence standard to show I did not deserve discipline. I am suing Indiana for the ADA violations. Straw v. Indiana, 2019-147 (Vt.) My VSB license is Active in Good Standing. 7/16"*
