WHAT IS MEDIATION?

Mediation is a process of intervention by an impartial, third party neutral, called a mediator, who facilitates communication between parties in a dispute. The mediator has no power to make decisions for the parties. Rather, the mediator's goal is to assist and encourage disputing parties in reaching a voluntary, fully-informed and mutually-acceptable agreement. The mediator uses his or her qualifications and experience to get the parties talking, to explore differences, to point out the strengths and weaknesses in each party's case, to ask questions and sometimes make private recommendations about the underlying merits of each side's case, and to communicate settlement offers and counteroffers to each side at appropriate times. Attendance at a mediation may be voluntary or ordered by a Court. However, the outcome is binding only if the parties

HOW DOES THE MEDIATION PROCESS WORK?

The mediation begins with an opening statement by the mediator describing the purpose of the mediation and the procedures to be used in the process. The parties may be present with their attorneys. The mediator then asks each of the parties to give an opening statement, in which the party may set forth his or her position and respective view on the merits of the underlying dispute. The parties' opening statements are followed by separate caucuses held by the mediator with each side. This is the heart and soul of the mediation process. Outside the presence of the other side, the mediator can examine, each side, the strengths and weaknesses of that party's case. The mediator will probe for settlement possibilities and communicate offers to each side when appropriate. The mediator continues to go back and forth between the separate caucus rooms, as the parties come closer and closer together, until they can agree on a mutually-acceptable result.

MEDIATION IS NOT ARBITRATION

An arbitration is a mini-trial in which the parties prove their claims by the introduction of witness testimony and documentary evidence. The arbitrator is expected to render a fair and impartial decision. In contrast, in a mediation, there is no "trial" and usually no formal introduction of evidence. The mediation process is neither adversarial nor contentious. Importantly, the mediator does not make decisions, but facilitates the

ADVANTAGES OF MEDIATION

Mediation provides a quick and relatively inexpensive way for contesting parties to settle their dispute or pending lawsuit. The alternative - litigation - can take an average of 1 to 3 years to resolve a case. Typically, a high percentage of disputes can be resolved in mediation in what is a comparatively short time. Most importantly, the parties get to choose their own result - a settlement can occur only if each side "chooses a result". In mediation, both sides know what the result will be. eliminating the risk of a jury or other decision-maker randomly and haphazardly deciding the case. In other words, both parties benefit in mediation.
